employer will attempt to use surveillance or Facebook as evidence. More often than not, we have a defense," Badey said, "Still, it makes things harder. I tell clients, 'Be careful.' If you are injured and you post on Facebook 'having a wonderful time at Disney World' that can create problems even where there are none."
