## MAJOR RECALLS TO START 2011

Already this year, the recalls have been plentiful. From medical supplies to vehicles and consumer products, Messa and Associates is keeping an eye out for recall news that may affect you.

**Honda Snowblowers:** American Honda is recalling red and black Honda snowblowers sold from April 2005 through November 2010. The snowblowers pose a serious fire hazard to consumers.

**Dodge Trucks and SUVs:** Nearly 150,000 Dodge Rams (years 2008-2011) and 2009 Dodge Journeys have been recalled by Chrysler for several issues.

**Albuterol:** 0.083% Albuterol Sulfate Inhalation Solution in 3 mL vials is being recalled because the vials are marked incorrectly and could cause medical professionals to increase dosage causing albuterol toxicity.
